OCASC and PIC Presentation

Hi, I'm Meaghan Allen, and I'm the School Council's OCASC Representative.

What does that mean?

OCASC stands for Ottawa Carleton Assembly of School Councils, and it's just that: schools in Ottawa, who have school councils, send a member of their council to monthly meetings where we discuss topics ranging from fundraising help to issues with secondary school students accessing courses, special education advice, the Arts, and equality issues such as equal opportunities (like access to math manipulatives) and racism.

It's really a means of enhancing our children's education by sharing information and facilitating communication between our many OCDSB communities[1]. OCASC has been serving the community since 1997. Membership is free.

Twice a month, the OCDSB holds a Standing Committee (a regular, permanent committee), called Committee of the Whole (COW)[2]. These meetings consist of the twelve elected Trustees, who have voting seats at the meeting. Our Trustee is Donna Blackburn. Additionally, there are two student voices, and ten other education-related organizations (like the Elementary and Secondary school Teachers' Federations) who actively participate in these meetings, but have non-voting seats.[3]

OCASC has one of these non-voting seats to represent the voices of parents. Having a non-voting seat allows OCASC the right to participate and express their opinions freely which is essential and fundamental. Parents need to have the opportunity to put forward our concerns, without restrictions or governed-oversight, for our children and their education.

The next acronym to know is PIC, which stands for Parent Involvement Committee. Your first thought may be "isn't that what a school council is"?! The answer is kind of, and I'll get to that momentarily.

Since 2011, the Ontario Ministry of Education requires school boards to have a PIC. PIC is board-managed, government-funded, and the majority of parents on the committee have applied and been selected by the Board, as opposed to school councils and OCASC, where those positions are voted for.

On page ten from the Government of Ontario's "A Practical Handbook for Parent Involvement Committee Members" [4], PIC's mandate is to:

- ♦ support, encourage, and enhance meaningful parent engagement at the board level to improve student achievement and well-being;
- provide information and advice to the board on parent engagement;
- ◆ communicate with and support school councils;

♦ undertake activities to help parents support their children's learning at home and at school.

So, to me, PIC is a government-mandated, board-managed and selected organization, whereas OCASC is "just" parent-run. Additionally, PIC has a Statutory Committee with the Board (in accordance with the Education Act)[5], and, as mentioned before, OCASC has a non-voting seat at the COW, the Board's Standing Committee.

One of PIC's mandates is to work with school councils (albeit, our PIC hasn't engaged with our school council in at least the past five years), and OCASC's is working with parents solely through school councils. PIC and OCASC can have overlapping view points and policies, but not always.

Currently, our PIC is undergoing administrative changes and are trying to become more involved. Recently, PIC went to delegate to COW, to ask to have a non-voting seat, like OCASC does. OCASC's communication officer supported this, as it would "[i]ncrease the opportunities for parent/caregiver involvement, engagement and voice at COW..."[6].

However, Trustee Boothby amended the proposal to have PIC replace OCASC at COW: her main reason was because of redundancy.

So, OCASC is at risk of losing its seat at the COW. This would mean that our school council, parent and community priorities may no longer be heard. We will no longer be able to affect change and policy in the same capacity that we've had for the last 23 years. If OCASC doesn't have this seat, they would have to submit to delegate to the Board. This means that if parents and/or school councils have an issue they'd like to bring up, the Board would initially listen for a maximum of four minutes[7] to perhaps discuss further.

OCASC also brings points discussed at COW to our communities to consult/discuss. Perhaps PIC would begin to do this, as it's in their job description, however, OCASC speaks to parents, for parents without anyone else's or any other governed-body's agenda at heart. OCASC is unbiased. PIC is not.

Please help us keep our seat at the table, and write into our trustees. We work so hard for our kids and school. Our voices need to be heard. Julia and I have drafted an email for other concerned parents to use as a template to send to Trustees. I will be sending this to you, our school's council members, and later to our parents. I also plan on hosting a parent information night/session to explain, basically, everything I have here.
